Glycoproteins

New title

This book covers the structure, biosynthesis and biological functions of glycoproteins. Discussion of structure starts with elementary carbohydrate chemistry and leads to an overview of the diversity of structure found in the glycoproteins. Comparisons are made, when appropriate, with the structure of glycolipids and proteoglycans. The section on biosynthesis highlights recent progress made in defining the specificity of protein glycosylation and its genetic control. In the final section the author describes the roles of carbohydrate in recognition and adhesion, in the controlled production of glycoprotein hormones, and the evidence accumulating for a relationship between abnormalities in glycoprotein metabolism and human disease.

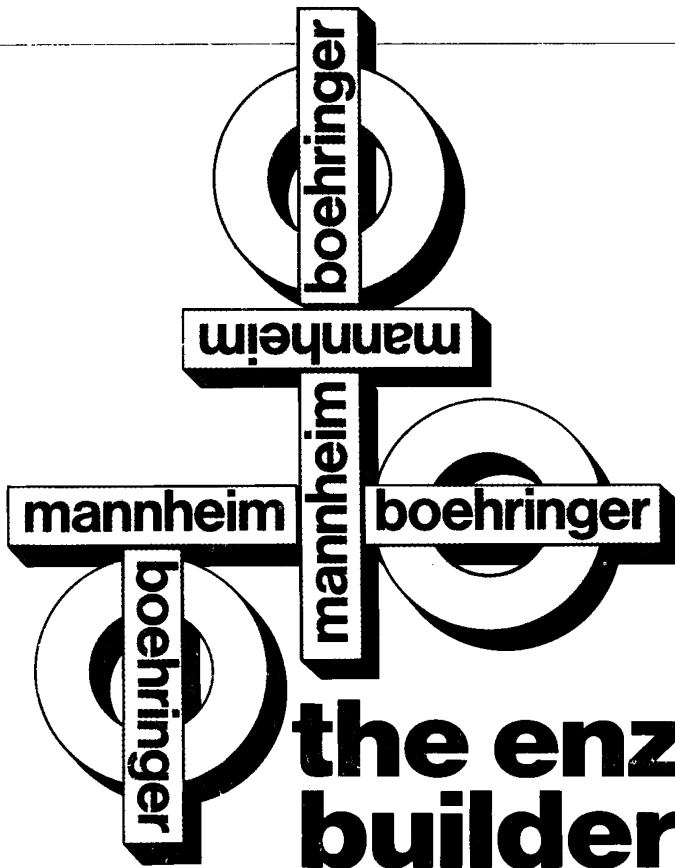
